- 9. The monitor wells report was reviewed. No action taken.
- 10. Meredith Allen provided a brief monthly drought update. No action taken.
- 11. Manager's Comments: a. Update on the Ditch and TWDB Grant 2021: Headgate construction to start soon, material costs have increased. b. GMA7- no update. c. Directives to Staff: Begin work on website, which is now required; update on legislative happenings in Austin; review options for insurance coverage on the Jeep, is full coverage required, or just liability only.
